REP. DAWN KEEFER: BRINGING OUR VALUES TO HARRISBURG

★ ELECTION INTEGRITY

I have been championing election law compliance and reforms since 2019. Ahead of this year's primary, I joined the Public Interest Legal Foundation and the America First Policy Institute to call on our counties to uphold their responsibility to ensure current and accurate voter rolls. Over the past eight years, more than 100,000 records have been identified in the state's voter registration system that are invalid due to duplication, death, relocation, non-citizenship or other disgualifying reasons.

As a member of the House State Government Committee, I have fought hard for the state and counties to follow election laws as written. To strengthen a foundational component of voter integrity, I signed a discharge resolution to bring House Bill 891 up for a vote. This legislation seeks to amend our state Constitution to require voters present a form of identification prior to casting a ballot. I also stood against proposed changes to election laws that not only would have harmed our current system, but also would have created more chaos and confusion for county election offices.

☆ CREATING ECONOMIC GROWTH AND FIGHTING OUT-OF-CONTROL INFLATION

House Bill 2339, bipartisan legislation I introduced with five of my colleagues, passed the House and is awaiting consideration in the Senate. The bill would require hospitals to maintain a publicly available list of all standard charges for hospital items and services in an easy-to-read format, as well as prohibit collection actions of debt for non-compliant hospitals. While this isn't a silver bullet for the issue of health care costs, it does establish transparency, and nothing can be accomplished without transparency.

☆ FULLY RESTORE BORDER ENFORCEMENT

I co-sponsored House Resolution 338, a resolution opposing unacceptable Biden/Harris open border policies and demanding full enforcement.

★ OPPOSING TAX INCREASES AND WASTEFUL SPENDING

This year's \$47.6 billion budget is an increase of \$2.7 billion, or 6%, when compared to last year's budget. This spending exceeds ongoing revenues the Commonwealth is anticipated to collect over the coming fiscal year by about \$3.3 billion, according to the Independent Fiscal Office. Compounding the reckless spending is the fact that the budget plan depends on borrowing, spends down reserve funds and will require tapping into the Rainy Day fund—or increasing taxes—within two fiscal years.

☆ PROTECTING FEMALE ATHLETES AND GIRLS' SPORTS

As a beneficiary of Title IX, I co-introduced and advocated for the Save Women's Sports Act (House Bill 216) to protect opportunities for our women and girls in athletics by ensuring they are not forced to compete against biological males playing on women's sports teams. Assuring women's rights are not eroded and that our young girls have the same athletic opportunities we've enjoyed the past 51 years is paramount.
